Case Number 17-712370 On 11/9/17 a simple assault was reported on campus characterized by a race bias. Unknown injuries as victim was unable to be located.

Case Number 17-713420 On 12/5/17 an intimidation/harassment was reported on campus characterized by a religion bias. There were no injuries.

Case Number 16-702597 On 3/26/16 an intimidation/harassment was reported on campus, characterized by a religion bias. There were no injuries.

Case Number 16-708493 On 10/17/16 an intimidation/harassment was reported in a residence hall, characterized by a race bias. There were no injuries.

Case Number 16-709390 On 11/9/16 a criminal mischief/vandalism was reported on campus, characterized by a religion and race bias. There were no injuries.

Case Number 15-701682 On 2/19/15 an intimidation/harassment was reported on campus, characterized by a disability bias. There were no injuries.

Case Number 15-702428 On 3/14/15 an intimidation/harassment was reported in a residence hall, characterized by a gender bias. There were no injuries.

Case Number 15-703590 On 4/18/15 an intimidation/harassment was reported on campus, characterized by a race bias. There were no injuries.
